Events:

Men's (MS) and women's (WS) single, men's (MD) and women's (WD) double and mixed doubles (XD). According to BWF rules, players born 2003 or later can be accepted. The maximum number of competitors accepted in the tournament are:

128 players in men's and women's single

64 pairs in men's and women's double

64 pairs in mixed doubles

No qualification will be played before the main draw. If an event does not have at least eight players (singles) or pairs (doubles) present in the tournament, the result of such event will not count for any ranking. If an event does not contain at least one entry from a member Association other than the hosting Association, this particular event shall not count towards any ranking. The organizer and Badminton Europe are not liable for any costs incurred by third persons. For more information kindly refer to the BEC U17 Circuit Regulation 2.3”

Draw

All events will be played in knock-out system. The seeding and the draw will be made by Badminton Europe on **19th November 2019**.

Condition of play

The tournament will be played in full accordance with the Laws of Badminton and the Competition Regulations adopted by the BWF as well as the Badminton Europe's U17 Circuit Regulations. Competitors must be prepared to play at the time determined for the events for which they have entered.

Doping control in badminton, in accordance with BWF Anti-Doping Regulations, is conducted out-of-competition and in-competition with the collection of urine and/or blood samples.

Athletes are responsible for any substance found in their body. Before an athlete takes any medication, they should check with their doctor, and if necessary, get a Therapeutic Use Exemption (TUE).

Badminton Integrity

Section 2.4 of the BWF Statutes (Code of Conduct in Relation to Betting, Wagering and Irregular Match Results) relates to anti-corruption and anti-match manipulation, and this code applies to all participants at this tournament.

To protect the integrity of BWF sanctioned tournaments, participants are not allowed to bet in any way on badminton matches, respect the principle of fair play, and shall not attempt to influence the course or result of a game or match.

Every person has an obligation to report to the BWF any approaches by anyone to gather inside information or to change the outcome of a matches.
